**ARENAS:** Show Arena dimensions are 120'x250'; Warm-up arena will be barn 7 arena. Show arena is climate controlled. Footing in all the rings is dirt.

**ATTIRE:** All riders, drivers, and attendants entered in Morgan classes shall be neatly and suitably dressed for their respective division upon entering the show ring. Riding suits are not required for entries entered in All Breed/Open classes. Long sleeves and closed toed boots are required.

**CHANGE/SPLITS/CANCELLATION:** Management has the right to combine, cancel or split any classes it deems appropriate. Management reserves the right to reschedule any class for the overall good of the show; exhibitors will be notified of such changes prior to the session starting. Morgan Classes that are labeled "17 and under" with more than 3 entries that fall into either "13 and under" or "14-17" in accordance to USEF age definition will be split into an A and B section.

**CLASS ANNOUNCEMENTS:** Please be aware class calls are a courtesy to the exhibitor. Show management is not responsible for an exhibitor missing a class, although every effort will be made to maintain a working P.A. system.

**COGGINS & HEALTH CERTIFICATES:** Proof of negative Coggins within the past 12 months and valid Health Certificate within 30 days of the last day of the show is required of every horse entering the OKCF. ***A copy of the test results must be presented to Health Inspectors at Gate 7 and the Show Secretary upon arrival. NO NUMBERS WILL BE ASSIGNED WITHOUT CURRENT TEST RESULTS.***

**FEED & BEDDING:** All stalls are 10x10 stalls with concrete floor. Bedding is available for purchase at the OKCF Feed & Bedding office: 405-948-6786. Absolutely no sawdust or similar fine particle bedding will be permitted. No stall walls may be removed.

**NUMBERS:** A number will be assigned to each horse at the time the completed entry is received. That number will stand for the entire show and must be displayed whenever the horse is in the ring.

**ALL BREED CLASSES:** Rider/Driver/Handlers entered only in this section are exempt from the AMHA Non-Member fee. Entries are allowed to cross enter in other classes in this horse show provided the requirements are met for those classes. No same horse and rider combination can enter walk/trot/jog classes and walk/trot/jog/canter/lope classes.

**REGISTRATION:** Morgan horses shown must be registered with the American Morgan Horse Assn. Inc., or the CLRC or the BMHS and must be entered under their full registered name and registration number, or if under one year of age, be eligible for registration. Horses must be entered under the names of the owner(s) or leasee of record with AMHA. A copy of the registration papers showing recorded ownership or proof of lease must be submitted with entry form at the time of entry. This only applies to horses that are competing in Morgan Designated classes. For horses eligible for life time and year end high point awards from WDAA, WDAAOK, ODS, AMHA, SSMHA or any other association please provide your horses registration numbers or any paperwork that is required of the show secretary for reporting purposes.

**DOGS/PETS:** No dogs or other pets are permitted on OKCF property, whether on a leash or not. Only bona fide assistance dogs, trained animals in scheduled acts or Oklahoma State Fair competitions or police dogs are allowed.

**FOOD SERVICE:** A concession stand will be open on the grounds. Hours of service will be posted.

**JUDGING:** A single-judge system shall be used for all classes.

**ENTRIES:** Entry and stall reservations must be accompanied with a check or money order, payable to the SOONER STATE MORGAN HORSE ASSOCIATION and mailed to: Show Secretary,  
Stephanie Edwards, 1825 SW 30<sup>th</sup> Street, Moore, Ok 73160

All entries must be made on the official entry blank, one owner per entry blank. Every exhibitor, rider, driver, handler, coach and trainer or his agent must sign an entry blank. In the case of a rider, driver or handler under the age of 18, his parent or guardian, or if not available, the trainer must sign an entry blank on the minor's behalf. Classes entered during the show require payment in full or an open check

deposited with the Show Secretary. Any change in rider, driver or handler or added classes must be made in the horse show office prior to the start for the session.

**POST ENTRIES: Post entry will be allowed for this show for All breed/Open classes.** For those showing in Morgan Classes post entry is allowed but will incur the \$25.00 post entry fee. **ALL HORSES** must be stalled: one horse per stall.

**REFUNDS/SCRATCHES:** Scratches for entries prior to 48 hours before the show date will receive a total refund of entry and stall fees minus the \$25 office fee. After the 48 hour deadline entry fees only are refundable IF ACCOMPANIED by a veterinary certificate. NO STALL FEES WILL BE REFUNDED AFTER THE 48 HOUR DEADLINE. Under no circumstances will any fees be refunded after the entry closing date without a veterinary certificate.

**RETURNED CHECKS:** There will be a penalty of \$50 charged if a check is refused by the bank for any reason. No checks will be processed through the bank a second time and must be covered by a money order, cashier's check or cash, in addition to the penalty.

**VETERINARIAN** will be on call during the competition.

**PROTECTIVE HEADGEAR:** All juniors riding in Hunter Seat Equitation sections, while riding anywhere on the competition grounds, must wear properly fitting protective headgear which passes or surpasses ASTM/SEI standards. Harness must be secured and properly fitted. Any exhibitor may wear protective headgear in any division or class without penalty by the judge.

**RESPONSIBILITY:** Every entry for competition will be under control of the Sooner State Morgan Horse Association Fall Showcase and the horse show management, but in no way shall Sooner State Morgan Horse Association Fall Showcase, and/or its owners, officers, directors, agents, employees, volunteers or personnel, be responsible for any loss, personal injury or damage to any horse exhibited, or for any article of any kind or nature that may be lost, destroyed or in any way damaged that may occur- even if the harm occurred as a result of the negligence of Sooner State Morgan Horse Association Fall Showcase, and/or its owners, officers, directors, agents, employees, volunteers or personnel. It shall be a condition of entry that each Exhibitor expressly assumes all risk of harm (including death or destruction) to him or herself and/or his or her agent, employees, associates, children, animals, or personal property. It shall also be a condition of entry that each Exhibitor shall hold Sooner State Morgan Horse Association Fall Showcase and its owners, officers, directors, agents, employees, volunteers and personnel; The City of Oklahoma City; the Oklahoma City Public Property Authority, The Oklahoma State Fair, Inc; and its officers, directors and employees; and AMHA blameless for any injury, loss or accident to his or her person or property, including his/her horse and equipment.

**BUY-A-CLASS: Morgan Classes may be purchased for a sponsorship of \$50.00.** After the class is bought, **all entries pay the normal entry fee of \$20.00** for the class including the person that bought the class.

**All Breed classes may be purchased for a Sponsorship of \$15.00, all entries pay the normal entry fee of \$15.00** for the class including the person that bought the class. Please indicate on your entry blank which time slot you would like the class to be held (see schedule for available time slots). If no slot is

specified or all slots are bought show management will place the class in the schedule accordingly. Show management reserves the right to arrange the schedule as they see fit. As classes are purchased, they will be posted to the Sooner State Morgan Horse Association's FaceBook Page and website.

**PROPERTY OF THE OKLAHOMA STATE FAIR: NO staples, screws, nails or anything else that perforates any wall/door/part of the stall is allowed; tape other than painter's tape is not allowed. Any damages to a stall with the aforementioned, or taped up bulletins, flyers, etc., with any kind of tape that leaves a residue, will be passed on to the person who did the damage.**

**ENTRY INTO the Oklahoma City Fairgrounds: All livestock must enter from GATE 7 and show necessary paperwork to enter OKCF. This includes a current Coggins and Health Certificate. The GPS address for Gate 7 is 3466 Black Gold Drive, Oklahoma City OK 73107. Gate 7 opens daily 6:30 a.m.-10:00 p.m. Stalls will be available starting at 12 p.m. Sunday, and the show office will be able to check you in until 10 p.m. Sunday night. Monday morning check in will start at 7 a.m. and all horses must be checked out with the show office by 8 p.m. Monday night. **All stalls must be vacated by September 20, 2021 at 8 p.m.****

**Ticket sales may not start until 10 a.m. at all gates, so exhibitors and guests need to be prepared to either purchase sufficient tickets online in advance or online via a mobile device upon arrival.** The latter option may cause HUGE backlog and delays so PLEASE pre-purchase admission tickets and obtain the discount and have them ready to show the attendants at the gate upon arrival.
